

FRANK CASE MAY GO TO JURY LATE THIS AFTERNOON

SPECIAL MESSAGE ON MEXICAN MIDDLE FOR THE CONGRESS

President Wilson at Work on Document and Will Read It in Person to House and Senate.

AMERICAN VIEWPOINT TO BE MADE VERY CLEAR

Congress Rallying to President Since Huerta Has Stated That Public Sentiment Doesn't Approve.

Washington, August 21.—President Wilson was at work tonight on a special message which he probably will read in both houses of congress next Monday, relating in detail the negotiations which have been conducted through his personal representative, John Lind, with the Huerta government in Mexico.

The decision to make a comprehensive statement on the situation to congress was reached today after the president had about concluded that the negotiations between Mr. Lind and Provisional President Huerta, since the exchange of notes had developed no new basis for discussion.

Wilson May Read Message. With his message, the president will present the two notes, setting forth the American suggestions to the Huerta government and its reply. Should he read the document himself, which he is being urged to do by members of his cabinet, and to which idea he is strongly inclined, it will be the first time since the days of President Washington that a president has communicated a matter of foreign policy in person to the legislative branch of the government.

While there was no information from the white house to indicate what object it was hoped to accomplish through a message at this time, there was a well-defined belief in official circles that President Wilson, when the reading of an address which will be the American viewpoint and the Huerta contentions before congress and the people of this country, and which also will be made public to the world generally, cannot but have an important effect on the situation in Mexico.

Congress Rallyes to Wilson. It is expected to be a partial answer to the intimations of Provisional President Huerta in his note that President Wilson stands alone in his Mexican policy and unsupported generally in congress.

AS SHE BEGS FOR LIFE HUSBAND KILLS WIFE

Mrs. Ethel Denson on Her Knees in Street When Husband Fired.

Tampa, Fla., August 21.—While on her knees pleading pitifully for her life, Mrs. Ethel Denson, of Key West, was shot to death on the street here tonight by her husband, Benny Denson. Two negroes were eye-witnesses to the tragedy, but were afraid to interfere.

Denson, who followed his wife from Key West here several weeks ago, discovered her working in a restaurant on Franklin street. He threatened to kill her if she did not return with him.

When Mrs. Denson started home her husband was waiting just outside the door, and started after her. She outran him three blocks, but fell on her knees exhausted. Denson rushed up and without a word fired two shots, either of which would have been fatal, physicians say.

SPEER PREPARING TO FIGHT CHARGES

Judge Will Attend Hearings Before Judiciary Committee—Georgia Delegation to Confer About Action.

Washington, August 21.—Federal Judge Emory Speer, of Georgia, charged with official misconduct in papers filed with the house committee on judiciary, will attend any hearings that the committee may have to take evidence in the case. He telegraphed today to Representative Hughes, of Georgia, a life-long friend and college classmate, asking that he arrange for his appearance at the proper time. Mr. Hughes immediately conferred with Chairman Clayton, of the committee, and later notified Judge Speer that he would be permitted to be present with counsel.

A conference of the Georgia delegation in the house for consideration of the Speer case has been called for tomorrow. The meeting will be held at the capitol and all members of the delegation, except Representatives Roddenberry and Edwards, who are out of the city, will attend. The purpose is to consider what course the delegation should adopt in view of the charges made against a federal judge within their state.

It is likely that a subcommittee of two or three will be appointed to review the charges before the committee, a right which Chairman Clayton will accord. The subcommittee will report to the delegation as to whether the charges are sufficiently serious to warrant action, which would probably be in the form of a resolution to be offered in the house by one of their number to impeach the judge. Such a resolution would be referred to the judiciary committee, which will resume consideration of the department of justice report next Monday.

Speers' Son-in-Law Denies Reports. Macon, Ga., August 21.—(Special.)—A. H. Heyward, Jr., son-in-law of Judge Emory Speer, today gave out a statement in which he brands as false the reports emanating from Washington that the attorney general's special agent in his report to the judiciary contains serious charges against Mr. Heyward.

Judge Speer needs no defense at my hands, said Mr. Heyward today, "but in so far as the report applies to me I denounce it as maliciously false. I have never been appointed by Judge Speer to any office, and I have occasionally been elected trustee in bankruptcy by the creditors and have been appointed by the referees as receiver and trustee of bankrupt estates. Judge Speer has never fixed the amount of my fee in any case. No exception to any fee paid me has ever been made by any creditor or other party at interest. My accounts are on file in the court and wholly disprove the reckless statements, if Attorney General McInerney or his spy, Lewis, is responsible for these statements, he is simply trying to divert criticism from himself on account of his officious meddling with the affairs of the United States judiciary."

DYNAMITE CHARGE FOR MAYOR GAYNOR

Enough of Explosive to Wreck New York City Hall Found Under Gaynor's Office Window.

New York, August 21.—A deadly charge of dynamite, three whole 10-inch sticks and two halves with a fuse and detonator, was discovered this afternoon near Mayor Gaynor's office window in the city hall. The bureau of combustibles found that the explosive was 40 per cent dynamite, the regulation blasting proportion, and the smallest fusing would, if exploded, have wrecked the city hall.

No Statement From Gaynor. Mayor Gaynor frequently receives threatening letters, but tonight he would make no statement regarding the possible connection between any previous threat by mail and the dynamite of today. It is just three weeks ago this month that he was shot in the neck by a so-called crank and so badly wounded that for several days it was feared he would die.

How Explosion Was Prevented. Experts of the bureau of combustibles state that the only thing which prevented a disastrous explosion was the presence of a strip of cotton wool wound so tightly about the base of the fuse that a spark could not reach the detonator. An edge of one dynamite stick was slightly scorched.

REUBEN ARNOLD BRANDS JIM CONLEY MURDERER OF LITTLE PHAGAN GIRL

Attorney for Defense Dwells on Horror of Convicting Man Upon Purely Circumstantial Evidence, and Cites Many Instances Where Such Action Has Resulted in Great Injustice to the Accused. Scores Detective Department Unmercifully and Charges They Concocted Story Which Conley Told on Stand.

Unless all calculations are upset the Frank case should be ready to go to the jury tonight, provided Judge Roan does not decide to postpone his charge until Saturday morning—in which event the case will reach the jury during the forenoon Saturday.

After that time it is all a matter of speculation as to the time the verdict will be returned. It may be returned in a few moments after the jury retires; again, it may be hours or days. The general opinion is, however, that Frank will know his fate some time Saturday.

LONGING FOR TOBACCO DROVE HIM TO MURDER

Jeffersonville, Ind., August 21.—Edward Morton, an inmate of the state reformatory here, stabbed and killed Charles Bartie, another inmate, late today. Morton said he bore Bartie no ill will and that he stabbed him so that he could be sent to the Indiana state prison at Michigan City, where the prisoners are given tobacco.

CONVICTS TO BE PUT ON ILLINOIS HIGHWAYS

Springfield, Ill., August 21.—Sentences of prisoners who do good work on state roads will be commuted ten days for each thirty they work on the highways, Governor Dunne announced today. The honor system will be used; convicts whose terms are under five years will be ineligible, and counties which are beneficiaries of the plan will be required to pay 60 cents a day to maintain each convict employed.

that's what he testified here at the trial. My recollection is that one single drop of blood contains 3,000 corpuscles. And he found these corpuscles on only one chip.

It's very probable that strands of hair have been blown from this jet to the latrine machine.

"The state not only has got no case, gentlemen, but they've got the bluest, blifflingest lot I've ever seen. The detectives say that Frank is a crafty, cunning criminal, when deep down in their heart of hearts they know good and well that their case is built against him purely because he was honest enough to admit having seen her that day. Every woman in Atlanta who keeps house, who wants to keep healthy, who wants to rear healthy babies, should attend the two lectures which will be given today on the dairy instruction car of the Southern railroad. The car is on the tracks under the Terminal Station, and is easily reached through the space to the right side of the Plaza.

Yesterday the lectures were especially designed to instruct the dairy-men and farmers, though every word of the lecture, and the informal discussion following was profitable and interesting. The car is fitted up with the latest inventions for the proper care, preservation and development of dairy products. There is literature being distributed, and the walls are hung with beauties of the cattle kingdom that out-reach the proverbial \$10,000 beauty class. There are lessons in dairying and farming placarded and easily memorized, and one can take them in their minds and keep them forever.

**Program for Today.**

The program today is especially designed to interest the consumer, and the lecturer is at all times ready to answer questions as he talks.

You may think you know all about washing out the milk bottles in which your milk is put when the dairyman brings it to you in a can, you know just what to do with it afterwards, but even with all that knowledge, if you go to the dairy this morning you will hear some simple things which can be easily done that will take nothing for knowledge, and you and the baby and every member of the family will be the better for knowing it.

Do not imagine that the lecture is made up of dry facts; that you are shown ugly bottles of microbes, or that you will be told continually what not to do. You will find yourself rather highly entertained, you will appreciate more than ever before the vital usefulness of the cow, and you will

lean forward and listen attentively, and inspired by the mysteries of milk and what it means—things about it you have never heard before. The idea of the dairy is necessary for milk will cease to seem a drudgery, and you will make up your mind that your home will not be complete until you have your own cow in the back yard and know just as much about her as the expert dairyman does about his. And your interest will extend; you will want the women of your state to know about it, and you will find yourself wondering what you can do to promote the cattle industry in Georgia.

Berlin, August 21.—The "International Athletic Federation" was formally organized here today, the United States, Great Britain, Canada, Australia, South America, Egypt, Belgium, France, Norway, Sweden, Denmark, Finland, Germany, Hungary, Austria and Switzerland being the charter members.
