August 23, 1913. The trial here of Thomas E. Watson, charged with sending obscene matter through the mails, ended abruptly at noon today when Federal Judge Rufus E. Foster sustained the motion of the defense quashing the indictment against the Georgia editor.



## WOULD LIMIT PARKING OF AUTOS TO 30 MINUTES

### Present Conditions Menace to Public Safety, Says Fire Chief

All parking of automobiles within a certain prescribed zone will be limited to thirty minutes if the ordinance which the committee on traffic regulations drafted, is passed by council. The committee met Tuesday morning to read the traffic regulations of other cities and to confer on Atlanta's needs. Everybody, Fire Chief Cummings included, seemed to think that if parking is prohibited the congestion of traffic will be almost entirely relieved. A number of minor regulations, however, will be incorporated in the ordinance, which will be drafted by the committee composed of Judge John S. Canfield, Jehu W. Grant and A. R. Colcord.

Fire Chief Cummings made a strong statement to the committee urging that the center of the city be cleared of the automobiles that line the curb all day and block traffic.

"My men can never get to the street without encountering these automobiles," said the chief, "and not long ago when the fire broke out in the Empire building they could not get a line or ladder to the sidewalk and they dropped back a block to Broad street and walked up the sidewalk to the point where the blaze was. Such a condition is a great menace to the public safety and to property, and should be remedied at all costs to the city."

The ordinance which will be drafted will include also regulations governing heavy traffic, street car stops, and pedestrians crossing streets.

The present law forbidding all traffic to be kept close to the curb also will be more strictly enforced.

The city attorneys will assist in drafting the ordinance, which will be presented to the general committee at another meeting next Tuesday.

One rainy afternoon, less than two years ago, five women met in the apartment of one of them in New York.

They met to talk about the climbing price of food. Perhaps, as they sipped their tea, they chatted a little about other things too, but FOOD was the main topic of their discourse.

The price of it was the leading thought, but in discussing how to get lower prices, the incidental questions of where and when, of sanitation and freshness and so on, came into the count.

There were just five of these women. They got busy. Today there are 750,000 in the organization which these five formed that rainy afternoon.



qualifying as a juror he answered every question truthfully and that his mind was open and impartial until "the state called the burden by an abundance of evidence."

At the time before the trial he declared he had no statement concerning his participation in the case. He had often said in the past that the man who killed Mary Pearson, whoever he might be, should be hanged.

He discussed the case a number of times in the matter and after the first ten days of the case, he seldom read anything in the newspapers about it except the headlines.

He stated that R. L. Gremer, who makes one of the Albany affidavits, is unknown to him. He adds that he understands that Gremer is a man of bad character. C. S. Hines is the maker of an affidavit in which he swears that he wouldn't believe (from) any path.

NOTE IN ALBANY.

Henslee swears that he was not in Albany between June 3 and September 18, and offers that affidavit as evidence there to support his contention. He doesn't remember any conversation in Albany with Black Hawk, but Gremer in June. He does remember talking to Sam Parsons, but he doesn't recall he made any statements showing prejudice.

He denies that he was within 500 miles of Atlanta at the time of the trial at the time Julia A. Lehan claims he made a remark on a train between the two places, showing prejudice.

As to the affidavit of C. P. Smith, Henslee said that after the affidavit was published he went to him and told him that he had read it. Henslee denies the statements which Samuel Aaron claims he made to the press of the Elk's club. The solicitor introduces the affidavits of T. M. Watson and two other men, who swear that they know Aaron and wouldn't believe him on oath.

DENIES PREGUDICE.

As to the affidavits of H. Nunnally and W. L. Ricker, Henslee admits that he might have mentioned his name in talking to them, but denies that he made any expression of opinion in either case or prejudice.

The affidavit of Gray, S. M. Johnson and John M. Holmes, of Sparta, are considered among the strongest against Henslee. In answering them Henslee pointed out the statements to the grand jury. He was in Atlanta on July 21, he asserts and came from there, where he received his subpoena, at 10 o'clock in the afternoon at his residence, at 74 Cecil street. He did not leave the city until after the trial, and consequently says that he could not have possibly had a conversation with the three gentlemen in Sparta after he had been drawn as a juror.

He did not see Sparta until September 2, he says after the trial. Then the gentlemen named congratulated him on the verdict in the case, he says, and in the course of the conversation said in answer to questions he believed that he believed Frank guilty and also that he believed the defendant in the murder case to be a pervert.


After his denial of the affidavit saying that he is prejudiced, Henslee made the same statements given in the affidavits by the other jurors.

Mr. Shilley says that he has not met the man who has been called upon to offer an alibi, but his own curiosity has established his whereabouts on April 22, the day that Mary Pearson was murdered in the pencil factory.

"I never saw this man who drove into the city with me in my wagon," remarked the juror, "but he drove into the city as a matter of fact my delivery wagon on driver, Louis Bruce, was in charge of it."

It also recalled that a few days after the murder, while it was being discussed, he remembered just where he was at a given hour on the certain date.
