General Diaz and his companions, once on board the Wheeling, soon recovered their equanimity, but this morning related their beliefs that they were to have been shot today.

Eraristo and Daniel Hernandez, relatives of the late president, who were arrested at Monterey for complicity in a plot to hand over that city to the rebels today landed in the prison of San Juan de Ulises.

John Lind, who received the order from Washington to return to Mexico, is said to have notified the state department that everything possible has been done.

IN IMMINENT PERIL. In his dispatch, the state department later said by him to Rear Admiral Fletcher, which he may have conveyed to the refugees were in imminent peril, and also that the rebels were to be released or another vessel until the arrival of instructions from Washington.

Rear Admiral Fletcher this afternoon declined to transfer General Diaz from Wheeling to one of the larger American war vessels, because the cruiser "Texas" is at sea.

LAUGH AT DIAZ. General Diaz, commander of the federal troops in Vera Cruz, appeared today to be somewhat derisive of the action of General Felix Diaz in taking refuge on board the Wheeling.

Under the army regulations a retired officer is entitled to a technical one change in his residence and General Diaz might come under this provision, as he is a retired officer.

Wheeling Left Expressly. As Boat for Refugees. (Associated Press.)

Greek Strikers Attack Coal Camps in Colorado and Plan to Battle Troops

TRINIDAD, Col., Oct. 27.—In a battle this morning between approximately 1500 strikers and 100 mine guards at the camp at Hastings, Dolores, Tobacco and Berling, one mine guard and three strikers are said to have been killed.

State Troops Rushed To Colorado Mines

DENVER, Oct. 28.—Eight companies of state troops in accordance with orders issued early today by Governor Ammons proclaiming a state of insurrection, have been rushed to the scene of the coal miners' strike in Huerfano and Las Animas counties.

The scene of the disturbance is in the two counties of which Walsenburg and Trinidad are the county seats. The mines are reached by branches from the Colorado and Southern railroad and from the Denver and Rio Grande, which parallels it a few miles westward.

The governor's orders to the adjutant general proclaim a state of insurrection, direct the disarming of both strikers and mine guards, order the closing of schools in the district, and the enforcement of the order against the importation of strikebreakers, and prohibit the intrusion on company property of all except company workers.

The conference had hardly begun before word reached the governor that the ordering out of the military came after a day of conferences. The strike leaders had visited several points and the prospects for a settlement seemed good when the military was ordered to district put a stop to further negotiations.

The supporters of the Tech eleven are optimistic today as the result of the signing of Lieutenant Leland R. DeVore, captain of last year's Army All-American tackle for three successive years, to coach the remainder of the season.

Lieutenant DeVore had already shown his ability as a coach by taking a green squad of soldiers of his regiment, the Seventeenth Infantry, stationed at Fort McPherson, and developing them into a coaching good team in four or five weeks.

With just the few days remaining between now and the Sewanee game the coaching of Lieutenant DeVore is expected to be seen in that regard.

Tuesday afternoon Coach DeVore will take the varsity line down to the tackle and teach them correct tactics in hitting the opposing line, and especially in breaking through for a tackle, which point of play on the defensive has been Tech's chief weakness.

Meek Hit 358 For Victoria

John "Butterfield" Meek, leading Southern league hitter in 1912, and who slumped below the 300 mark the following year and followed the slump only because the Birmingham management thought this thing was a fluke, was on him this year led the fast Northwest league in hitting with an average of .358 for the Victoria club.

Meek has the old distinction of hitting 300 or over for three consecutive years in minor leagues with the exception of 1907 when he slumped to .287. This was his only falling off.
